
Call for Submissions: Bodies in Motion



In the spirit of the 2024 Summer Olympics, we cordially invite artists to submit their works for consideration in our next group exhibition, *Bodies in Motion*, on view at the 20*20 House in Lansdowne, PA from **Saturday**, **September 21st** to **Sunday**, **November 24th**, 2024.

This call is open to artists working in any visual or performance-based medium: In addition to 2D, 3D, and video media, we welcome submissions from artists, dancers, and choreographers to create site-specific performances to be held outdoors on the campus of the 20*20 House or 20th Century Club in Lansdowne, PA and performed on **September 29th**. We are interested in work that celebrates the incredible diversity of motion and emotion that can be expressed by the human body in all its myriad shapes, sizes, age and ability. All submitted work should be original and one-of-a-kind.

Submissions will be juried by the Lansdowne Arts Committee. Submissions are due by 11:59 PM on August 30th, 2024. Artists will be notified of their acceptance by September 6th, 2024. Physical and new media artwork must be hand-delivered on September 14th between the hours of 11am - 4pm to the 20*20 House Gallery (20 Lansdowne Court, Lansdowne, PA) and pick up will be scheduled between the artists and the Lansdowne Art Committee. Mailed artwork will not be accepted.

Wall-based artwork must be framed or otherwise be ready to hang using appropriate hardware. Work needing magnets, velcro, putty, etc., to hang will not be accepted. Only one submitted artwork can have dimensions exceeding 48". Artists who wish to display video-based media should be prepared to provide their own technology (tablet, laptop, projector, etc), mounts, and instructions. They may be required to be present during the installation period.

- Artwork drop off: September 14th
- Run of show: September 21st November 24th (Gallery open noon 4pm Saturday and Sunday)
- Reception and Performances: September 29th

- Artwork pickup will be scheduled between the artist and the Lansdowne Art Committee

To apply, please submit the following materials:

- Physical artwork and new media:
 - Up to 5 artworks for consideration (only one artwork may exceed 48" in any direction)
 - A brief artist statement outlining your concept and approach to the theme of "bodies in motion."
 - An artist bio and statement
- Dance and performance:
 - One PDF with up to five links to recordings of dance/performances along with the length of performance, information about any technical, space, or equipment needed to support the performance, and a short (one paragraph) description.
 - A brief artist statement outlining your concept and approach to the theme of "bodies in motion."
 - An artist bio and statement
